#### John Lamberti President's Report:

Discussion from members included both pros and cons of moving players up. Members stated that we may consider a rule that players must play at least one year in each division, and noted the cons of moving children up while skipping a division including child development (not baseball skill) and the strength of older players. Some members stated that the LL rules do allow for younger ages to join the next division up. Some members stated that players should be allowed to go to evaluations to see their abilities, while others argued that it may open a can of worms for younger players to be pushed to higher divisions. The board concluded that a vote would take place in the immediate future.
