 - [Dunn]- Option could be to enter 1 team per level to Cal Ripken as Travel Ball in Spring
 - [VP]- Tournaments are charged per person, but only at Regional Level (Mid-Atlantic tournaments \$500/person)
 - End of Year to make a decision
 - League Fees LLI vs. Cal Ripken
 - [Treasurer]- Charter Fees per team for Cal Ripken:
 - Majors @1M Liability Coverage: \$126
 - Majors @2M Liability Coverage: \$170
 - Charter Fees per team at LLI
 - \$78 per team (needs to be confirmed)
